Background


Staff received the abstract of votes for the November 8, 2016 General Election from Lane County Elections Office on November 28, 2016. According to Oregon State Election laws, the City Council must adopt a proclamation declaring the results of the measures. The deadline for adopting the proclamation was December 8, 2016, however the first City Council meeting since receiving the abstract is December 12, 2016.
